Sub: Information required under Right to Information Act, 2005

Please refer to your RTI appeal dated September 10, 2025 received by Stock Holding Corporation of India Limited ("Stock Holding") on September 12, 2025.

In this context, please find our replies to the prayer/relief sought by you as mentioned below:-

a) Please provide the entities empanelled with SHCIL for collection and of stamp duty through the API (Para 3(a)(ii)).

Currently the following entities are empanelled with Stock Holding for collection of stamp duty through API:

- M/s. Desk Nine Private Limited (operating under the brand name "Legaldesk")
- M/s. National e-Governance Services Limited (NeSL)
- M/s. Grey Swift Private Limited (operating under the brand name "Leegality")

b) Please provide the details of the authorizations obtained by Desk Nine Private Limited for electronic collection and payment of non-judicial stamp duty through the API provided by SHCIL. (Para 3 (a) (v))

The issuance of e-stamps in digital form is subject to obtaining specific approval from the respective state government. Further, authorization from the clients in favour of M/s. Desk Nine Private Limited is required to enable them to pay the stamp duty and collect e-stamp certificates on behalf of the clients.

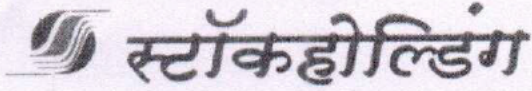


